TRAINING

- Janet Perales – OPS Quality Control Analyst – What is Hospice
 - A resident qualifies for hospice care if is under Medicare Part and meets criteria.
 - Hospice doctor and PCP certify the individual is terminally ill.
 - The individual accepts comfort (palliative care) instead of care to cure the illness.

- If qualified, the individual gets hospice care for two 90-days benefit periods, followed by an unlimited number of 60-day benefit periods.
- Patients pay nothing for hospice care if the individual gets care from Medicare-approved hospice.
- After 6 months or less the patient can continue to get hospice care as long as the hospice medical director or hospice doctor recertifies.
