Please make sure every time you enter a facility a Case that you enter the "Entering facility verbiage" quick note before you write your notes about the case. For a RAV there is a quick note that has the entering verbiage as well as the categories listed in bold. These should be available to all users, so if you do not find them, please let me know.
