- <u>District Ombudsman Manager</u> Terre Anne Lindstamer

 - Certified Ombudsmen and Military Veterans Mrs. Donna Holden and Mr. Orrin Schaal were recognized and thanked for their service to our country. Both served in the United States Air Force.

 - o State-wide travel restrictions are no longer in effect.

- o The Program's reentry policy is completed, and I will send it to our Ombudsmen tomorrow via email plus a hard copy will be mailed.
